

REGISTRATION FEE – Information updated on 8 March 2023

Dear Colleagues,

In order to complete your registration for the ICRM 2023 conference, please, pay the Registration fee as soon as possible.

The payment method is by bank transfer. You can also pay in cash at the conference.

For the paper presentation and publishing, at least one author must register and attend the conference in-person, at Bucharest.

In order to participate to the conference:

1. Get the approval of the management of your institution (institute/university etc.) for your participation to ICRM 2023;
2. Ask an Invoice from the organizers of ICRM 2023 and provide all the necessary details (institute/university name and postal address, VAT code etc.), at icrm2023@nipne.ro and Cc: aluca@nipne.ro
3. After you receive the Invoice by e-mail, please, pay the invoice (by bank transfer) and send some payment proof by e-mail to icrm2023@nipne.ro (a copy of a payment order /statement of bank account).

The invoice in original will be given to you at the conference or sent by post.

The early registration fee is 600 EUR/participant and the payment deadline was 27 January 2023;

The normal registration fee is 650 EUR/participant to be paid during 28 January 2023 – 25 March 2023, for participants registered on the web page until 13 March 2023;

The on-site registration fee is 700 EUR/participant (for participants not registered on the conference web page until 13 March 2023) and can be paid in cash only, at the conference, on 27, 28 or 29 March 2023 (ask the organizers).

The online registration fee (for remote participation by ZOOM) is 200 EUR/participant to be paid until 13 March 2023, by wire transfer.

For students, master's students and PhD students there will be a reduced registration fee (in-person participation): 300 EUR/participant to be paid until 13 March 2023, by wire transfer.

For the COMMERCIAL COMPANIES representatives: 600/650/700 EUR/participant, depending on the payment period.

For more details, including the registration fee for the participants from Romania (Romanian and foreign citizens from Romania), see below (no. 7).

1. The Registration fee for in-person participation (600/650/700 EUR/participant) and the Registration fee for students (300 EUR/in-person participant) includes:

- participation to the conference sessions (oral and poster presentations), ICRM WGs meetings and other meetings organized during the week of the ICRM 2023 at the same location;
- Conference program and abstract book;
- conference bag and promotional items;
- lunches, coffee-breaks and other catering services during the conference (5 days);
- informal reception at the registration;
- conference dinner and Romanian traditional music and dance show (transport included);
- visits to the Parliament Palace in Bucharest (transport included) and Romanian Athenaeum (situated near the conference location) ;
- visits to IFIN-HH, including ELI-NP and the ionizing radiation metrology laboratory (transport included).

2. For the student registration fee, the participant will submit to the organizers (by e-mail to icrm2023@nipne.ro) a document issued by the University (pdf scanned copy), confirming that the participant is a student or master's student or PhD student (deadline: 13 March 2023).

3. **The online registration fee (200 EUR/participant)** allows to watch (by ZOOM) the conference sessions and WGs meetings and to ask questions and make comments using the chat (ZOOM). The participant will have access to the Conference Program, Abstract Book and other conference documents. It will not be possible to present papers at the conference by the online participant (oral or poster). Only the in-person registrants can present papers at the conference. The online participants can present contributions within the ICRM WG Meetings.

4. **The registration fee for one accompanying person is 200 EUR** and it includes the participation to the conference dinner and Romanian traditional music and dance show, informal reception at the registration, visits to the Parliament Palace in Bucharest (transport included) and Romanian Athenaeum (situated near the conference location).

5. **For COMMERCIAL COMPANIES: the participants will pay only the registration fee of 600/650/700 EUR/participant, depending on the time of the payment.** For more details about the exhibition, commercial presentations during the lunch breaks and other facilities, please, contact Mrs. Daniela ZAMFIR (daniela.zamfir@nipne.ro).

6. The registration fees mentioned above represent the amount to be paid in the IFIN-HH bank account. Any taxes/fees for the bank transfer will be supported by the person/institute/company that makes the payment.

7. **ONLY for the participants from Romania (Romanian and foreign citizens):**

The conference participants working at IFIN-HH will not pay the registration fee; the costs of their participation will be covered from the departments overhead.

The Romanian and foreign participants living in Romania, which are not employees of IFIN-HH, can pay the registration fee in Lei (RON) at the exchange rate of BNR (Romanian National Bank) on the day when the payment is done. 8. If a person has paid the registration fee and, for justified reasons, cannot participate to the conference or has to leave before the end of the conference, then this person can recover partially the registration fee.
